## RENTAL CAR REIMBURSEMENT

Up to \$35 per day for up to 10 days, if required, due to a covered mechanical breakdown.

## TRIP INTERRUPTION REIMBURSEMENT<sup>7</sup>

Up to \$200 per day for up to five (5) days per incident, in the event of a covered mechanical breakdown occurring more than 100 miles from home that requires an overnight repair.

1. Replacement parts utilized in covered repairs will be new or remanufactured parts of like kind and quality, to be determined at the Administrator's discretion.
2. Hybrid/electric high-voltage vehicle batteries are excluded from coverage.
3. Additional exclusions may apply. Please see your Agreement for specific coverage details, including limitations and exclusions.
4. Emergency Roadside Assistance services are available, up to \$100 per occurrence.
5. If the covered vehicle is inoperable or unsafe to drive, it will be towed to the selling dealer or the closest repair facility, up to \$100 per occurrence.
6. Up to three (3) times per 12-month period.
