

## WHAT'S NOT COVERED<sup>10</sup>

- Mechanical breakdowns covered by the manufacturer's or other applicable warranty;
- Mechanical breakdowns due to collision or any event not connected to the normal use of your vehicle;
- Physical damage or repairs to bumper, body parts, & sheet metal;
- Glass, lenses, sealed beams, & light bulbs;
- Mechanical breakdowns due to preexisting conditions;
- Maintenance services or parts;
- Tires, batteries (including hybrid & EV battery packs/modules & hybrid & EV chargers & charging cords), struts, shocks, brake pads, brake rotors, & brake drums;
- Non-manufacturer installed accessories;
- Carpet, hinges, trim, upholstery, convertible or vinyl tops, moldings, bright metal, plastic, chrome, air & water leaks, wind noise, weather strips, squeaks & rattles, paint, & rust;
- Exhaust system, including the catalytic converter.

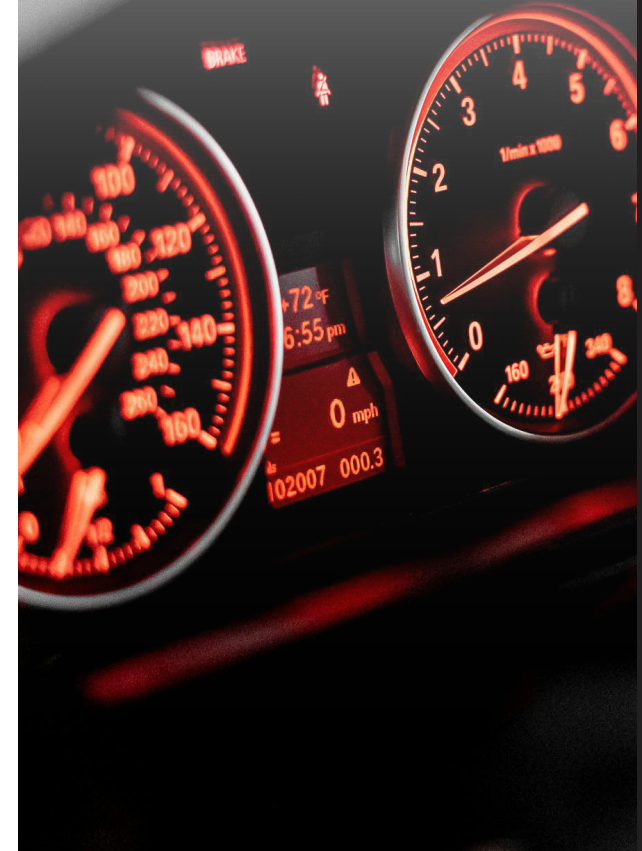

OSI Ultimate Coverage is designed to ease your mind and get you back in the driver's seat.

Covered Parts under OSI Ultimate Coverage include some of your vehicle's most essential systems. As an example, a few of the Covered Parts<sup>5</sup> include:

## WHAT'S COVERED<sup>6</sup>

- **Extensive Protection:**  
Covered Parts include electronic, electrical, & mechanical parts, in the event of a breakdown, unless they are excluded;
- **Deductible Options:**  
\$0, \$100 Disappearing,<sup>7</sup> & \$200;
- **Rental or Rideshare Assistance:**  
Up to \$50.00/day, max 7 days, per Covered Repair;
- **Towing Assistance:**  
Up to \$150.00 per Covered Repair;<sup>8</sup>
- **Trip Interruption Assistance:**  
Up to \$200.00/day, max 3 days, for restaurant & hotel expenses incurred during trip;
- **Roadside Assistance:**  
Up to \$150.00 per emergency for listed roadside emergencies;<sup>9</sup>
- **Transferable:**  
In some cases, the Contract may be transferred to a private-party purchaser, which may increase your vehicle's resale value.
